

**ORDINANCE NO. 8**

**“Butman Township Insurance Plan Ordinance”**

An Ordinance to create and establish a township group insurance plan covering life, health, hospitalization, medical and surgical service and expense and accident insurance for certain classes of township officers and employees and their dependents and to authorize the township supervisor and the township clerk to contract, in the name of the township, for such plan; to define those classes of officers and employees who shall be covered by such group insurance plan; to set forth the respective per centum shares which Butman Township and the officers and employees shall contribute to the premium of charges arising under such group insurance plan and further provide for the deduction of contributions from officers and employees compensation; to provide a method for non-coverage of an officer or employee of the group insurance plan; to ratify and confirm the validity of any group insurance plan in existence of the effective date of this Ordinance; and to repeal all Ordinances or parts of ordinances in conflict herewith.

ORDINANCE # 8

BUTMAN TOWNSHIP INSURANCE COVERAGE

AN ORDINANCE TO CREATE AND ESTABLISH A TOWNSHIP GROUP INSURANCE PLAN COVERING LIFE, HEALTH, HOSPITALIZATION, MEDICAL AND SURGICAL SERVICE AND EXPENSE AND ACCIDENT INSURANCE FOR CERTAIN CLASSES OF TOWNSHIP OFFICERS AND EMPLOYEES AND THEIR DEPENDENTS AND TO AUTHORIZE THE TOWNSHIP SUPERVISOR AND THE TOWNSHIP CLERK TO CONTRACT, IN THE NAME OF THE TOWNSHIP, FOR SUCH PLAN; TO DEFINE THOSE CLASSES OF OFFICERS AND EMPLOYEES WHO SHALL BE COVERED BY SUCH GROUP INSURANCE PLAN; TO SET FORTH THE RESPECTIVE PER CENTUM SHARES WHICH BUTMAN TOWNSHIP AND THE OFFICERS AND EMPLOYEES SHALL CONTRIBUTE TO THE PREMIUM OR CHARGES ARISING UNDER SUCH GROUP INSURANCE PLAN AND FURTHER PROVIDE FOR THE DEDUCTION OF CONTRIBUTIONS FROM OFFICERS' AND EMPLOYEES' COMPENSATION; TO PROVIDE A METHOD FOR NON-COVERAGE OF AN OFFICER OR EMPLOYEE OF THE GROUP INSURANCE PLAN; TO RATIFY AND CONFIRM THE VALIDITY OF ANY GROUP INSURANCE PLAN IN EXISTENCE ON THE EFFECTIVE DATE OF THIS ORDINANCE; AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

SECTION 1:

THIS ORDINANCE SHALL BE KNOWN AND CITED AS THE " BUTMAN TOWNSHIP INSURANCE PLAN ORDINANCE."

SECTION 2:

PURSUANT TO PUBLIC ACT 77 OF 1989, THE TOWNSHIP OF BUTMAN HEREBY CREATES AND ESTABLISHES A GROUP INSURANCE PLAN COVERING LIFE, HEALTH, HOSPITALIZATION, MEDICAL AND SURGICAL SERVICE AND EXPENSE AND ACCIDENT INSURANCE OF ITS OFFICERS AND EMPLOYEES ENUMERATED HEREIN, AND THEIR DEPENDENTS, AND FOR SUCH PURPOSES, ALSO HEREBY AUTHORIZES THE TOWNSHIP SUPERVISOR AND THE TOWNSHIP CLERK TO CONTRACT, IN THE NAME OF THE TOWNSHIP BOARD, SUBJECT TO APPROVAL OF THE BOARD, WITH ANY COMPANY AUTHORIZED TO TRANSACT SUCH BUSINESS WITHIN THE STATE OF MICHIGAN FOR SUCH GROUP INSURANCE POLICIES.

SECTION 3:

THE GROUP INSURANCE PLAN CREATED, ESTABLISHED AND CONTRACTED FOR UNDER THIS ORDINANCE SHALL COVER EACH PERSON WITHIN THE FOLLOWING CLASSES OF OFFICERS AND EMPLOYEES AND SHALL ALSO COVER THE DEPENDENTS OF SUCH PERSONS:

- ( ) ALL MEMBERS OF THE TOWNSHIP BOARD.
- ( ) ALL MEMBERS OF THE TOWNSHIP ZONING BOARD.
- ( ) ALL MEMBERS OF THE TOWNSHIP PLANNING COMMISSION.
- ( ) ALL MEMBERS OF THE TOWNSHIP ZONING BOARD OF APPEALS.
- ( ) ALL MEMBERS OF THE TOWNSHIP BOARD OF REVIEW.
- ( ) ALL MEMBERS OF THE TOWNSHIP PARK BOARD.
- ( ) ALL MEMBERS OF THE TOWNSHIP LIBRARY BOARD.
- ( ) ALL TOWNSHIP CONSTABLES.
- ( ) ALL TOWNSHIP BUILDING INSPECTORS AND THEIR ASSISTANTS.
- ( ) ALL TOWNSHIP FIRE CHIEFS.
- ( ) ALL TOWNSHIP POLICE CHIEFS.
- (X) ALL TOWNSHIP EMPLOYEES WHO ARE EMPLOYED FOR MORE THAN TWENTY (20) HOURS PER WEEK ON A REGULAR BASIS.
- ( ) ALL TOWNSHIP VOLUNTEER FIREMEN.

- ( ) ALL TOWNSHIP VOLUNTEER AMBULANCE DRIVERS OR ATTENDANTS.
- ( ) THE TOWNSHIP ATTORNEY, ENGINEER AND THE TOWNSHIP ACCOUNTANT.
- ( ) THE TOWNSHIP UNSAFE BUILDINGS HEARING OFFICER.
- ( ) THE TOWNSHIP MANAGER.
- ( ) ALL MEMBERS OF THE TOWNSHIP RECREATION BOARD.
- ( ) ALL TOWNSHIP ASSESSORS.

SECTION 4:

THE TOWNSHIP OF BUTMAN SHALL ANNUALLY CONTRIBUTE 100 PER CENTUM OF THE PORTION OF THE PREMIUM OR CHARGES ARISING UNDER SUCH LIFE INSURANCE CONTRACT FOR EACH PERSON WITHIN THE CLASS OF PERSONS ENUMERATED IN SECTION 3 HEREOF. ADDITIONALLY, THE TOWNSHIP OF BUTMAN SHALL ANNUALLY CONTRIBUTE 100 PER CENTUM OF THAT PORTION OF THE PREMIUM OR CHARGES UNDER SUCH HEALTH, HOSPITALIZATION, MEDICAL AND SURGICAL SERVICE AND EXPENSE AND ACCIDENT INSURANCE CONTRACT FOR EACH PERSON WITHIN THE CLASS OF PERSONS ENUMERATED IN SECTION 3 HEREOF. SUCH TOWNSHIP CONTRIBUTION SHALL BE SECURED FROM THE GENERAL AND ENTERPRISE FUNDS OF THE TOWNSHIP. EACH PERSON WITHIN SUCH CLASS SHALL BE RESPONSIBLE FOR THE REMAINDER OF THE PREMIUM OR CHARGES NOT PAID FOR BY THE TOWNSHIP AND THE TOWNSHIP TREASURER IS HEREBY AUTHORIZED TO DEDUCT THE SAME FROM EACH PERSON'S PAY, SALARY, OR COMPENSATION AND TO APPLY TO SUCH PERSON'S RESPONSIBILITY. ANY PERSON DESIRING NOT TO BE INSURED OR COVERED, AND IF THE NOTICE IS RECEIVED BEFORE THE PERSON HAS BECOME INSURED OR COVERED UNDER THE CONTRACT, HE/SHE SHALL NOT BE COVERED THEREUNDER. IF THE NOTICE IS RECEIVED AFTER THE INDIVIDUAL HAS BECOME INSURED OR COVERED, HIS COVERAGE UNDER THE CONTRACT SHALL CEASE AS PROVIDED FOR IN THE CONTRACT.

SECTION 5:

THE TOWNSHIP OF BUTMAN HEREBY RATIFIES AND CONFIRMS THE VALIDITY OF ANY LIFE, HEALTH, HOSPITALIZATION, MEDICAL AND SURGICAL SERVICE AND EXPENSE AND ACCIDENT INSURANCE OR ANY ONE OR MORE OF SUCH FORMS OF INSURANCE IN EXISTENCE ON THE EFFECTIVE DATE OF THIS ORDINANCE.

SECTION 6:

THIS ORDINANCE SHALL TAKE EFFECT ON THE DATE OF ITS PUBLICATION. ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HERewith ARE HEREBY REPEALED.
